

NC FIT Design

- Preparedness: Support CERT, Provide Community Outreach, Foster Individual Preparedness, Build Resilience
- Hazard Mitigation: Assess Risk, Develop Risk Reduction Strategies and Plans, and Enhance Statewide Resiliency
- Response/Operational Planning: Incident Management Plans, State Plans, Synchronize State/FEMA plans
- Recovery: Mass Care Plans, Disaster Housing Plans, Individual Assistance Guidance

FEMA Integration Teams

- Two roles: Regular duties and Disaster Duties
- “We are the help before the help arrives.”
- FIT members fold into the FEMA Regional and National deployed teams to serve where needed most during disasters.



FIT Duties

- FIT Can:

- Participate in State Planning Efforts
- Provide State and Local partners with consultation and technical advice
- Provide explanation of FEMA programs
- Support outreach and preparedness activities
- Support SEOC activations

- FIT Can't:

- Write State plans solo
- Replace State Capability
- Write Project Worksheets for Public Assistance
- Complete Grant Applications for State Agencies
- Change FEMA Policy

- **Future Operational Planning** *Courses of Action, Forecasting, Cascading Effects, Community Lifelines*
- **Crisis Action Plans** *Incident Action Plans, Incident Support Plans, Disaster COOP Plans, Logistics Plans*




Operations Planning

National Frameworks

- Summarize roles and responsibilities
- Cover core capabilities
- Define coordinating structures
- Describe relationships between mission areas

Federal Interagency Operational Plans

- Integrate and synchronize federal capabilities
- Describe critical tasks and responsibilities
- Provisions for rapid integration of resources and personnel
- Supersede existing annexes to the National Response Framework

Community Lifelines Defined

A lifeline enables the continuous operation of **government functions and critical business**, and is **essential to human health and safety or economic security**.



- Lifelines are designed to highlight priority areas and interdependencies, focus attention on actions being taken, communicate coordination efforts towards stabilization, and integrate information

Hazard Mitigation Grants

- Long-term risk reduction following a federal disaster declaration
- Goal is to prevent future losses
